## Website Terms and Conditions of Use

### 1. About the Website

- 1.1. Welcome to [www.aesthete-studio.com](http://www.aesthete-studio.com) (the '**Website**'). The Website provides you with an opportunity to browse and purchase various E-products and services that have been listed for sale through the Website (the '**Products**'). The Website provides this service by way of granting you access to the content on the Website (the '**Purchase Services**').
- 1.2. The Website is operated by Jessica Christie t/a Aesthete Studio (abn: 21 964 901 474). Access to and use of the Website, or any of its associated Products or Services, is provided by Aesthete Studio. Please read these terms and conditions (the '**Terms**') carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.
- 1.3. Aesthete Studio reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Aesthete Studio updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

### 2. Acceptance of the Terms

You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Aesthete Studio in the user interface.

### 3. Registration to Use the Services

- 3.1. In order to access the Services, you may be required to first register for an account through the Website (the '**Account**').
- 3.2. As part of the registration process, or as part of your continued use of the Services, you may be required to provide personal information about yourself (such as identification or contact details), including:
  - a) Email address.
  - b) Preferred username.
  - c) Aesthete Studio.
- 3.3. You warrant that any information you give to Aesthete Studio in the course of completing the registration process will always be accurate, correct and up to date.
- 3.4. Once you have completed the registration process, you will be a registered member of the Website ('**Member**') and agree to be bound by the Terms.
- 3.5. You may not use the Services and may not accept the Terms if:
  - a) You are not of legal age to form a binding contract with Aesthete Studio; or

- b) You are a person barred from receiving the Services under the laws of Australia or other countries including the country in which you are resident or from which you use the Services.

#### 4. Your Obligations as Member

4.1. As a Member, you agree to comply with the following:

- a) You will use the Services only for purposes that are permitted by:
  - i. The Terms; and
  - ii. Any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions
- b) You have the sole responsibility for protecting the confidentiality of your password and/or email address. Use of your password by any other person may result in the immediate cancellation of the Services;
- c) Any use of your registration information by any other person, or third parties, is strictly prohibited. You agree to immediately notify Aesthete Studio of any unauthorised use of your password or email address or any breach of security of which you have become aware;
- d) Access and use of the Website is limited, non-transferable and allows for the sole use of the Website by you for the purposes of Aesthete Studio providing the Services;
- e) You will not use the Services or the Website in connection with any commercial endeavours except those that are specifically endorsed or approved by the management of Aesthete Studio;
- f) You will not use the Services or Website for any illegal and/or unauthorised use which includes collecting email addresses of Members by electronic or other means for the purpose of sending unsolicited email or unauthorised framing of or linking to the Website;
- g) You agree that commercial advertisements, affiliate links, and other forms of solicitation may be removed from the Website without notice and may result in termination of the Services. Appropriate legal action will be taken by Aesthete Studio for any illegal or unauthorised use of the Website; and
- h) You acknowledge and agree that any automated use of the Website or its Services is prohibited.

#### 5. Payment

- 5.1. In using the Purchase Services to purchase the Product through the Website, you will agree to the payment of the purchase price listed on the Website for the Product (the '**Purchase Price**').
- 5.2. Payment of the Purchase Price may be made through direct deposit, credit card, PayPal or Stripe. (the '**Payment Gateway Providers**')
- 5.3. In using the Purchase Services, you warrant that you have familiarised yourself with, and agree to be bound by, the applicable Terms and Conditions of Use, Privacy

Policy and other relevant legal documentation provided by the Payment Gateway Providers.

- 5.4. Following payment of the Purchase Price being confirmed by Aesthete Studio, you will be issued with a receipt to confirm that the payment has been received and Aesthete Studio may record your purchase details for future use.
- 5.5. Aesthete Studio may, at their sole discretion, provide a refund of the Products within 7 days where the Product does not meet your requirements. You acknowledge and agree that you are liable for any administration costs associated with any refund pursuant to this clause.

## **6. Refund Policy**

### **For Services and Eproducts**

- 6.1 Aesthete Studio will only provide you with a refund of the Services Fee according to the individual Service Agreement.
- 6.2 Eproducts may be refunded if the manager of Aesthete Studio makes a decision, at its absolute discretion, that it is reasonable to do so under the circumstances (the '**Refund**').

### **For Event/Workshop Tickets**

- 6.3 If an event/workshop is cancelled or rescheduled before the scheduled start date and time, for any reason whatsoever, refunds or partial refunds may be issued. Aesthete Studio will communicate with ticket holders directly.
- 6.4 Aesthete Studio will not be liable for any loss or damage arising from any cancellation, rescheduling or alteration of an event.
- 6.5 With the exception of 6.3 above, ticket purchase fees are not refundable in any other circumstances.
- 6.6 Tickets may be transferred to another individual. To do this you must advise Aesthete Studio of the transfer in writing by email to [hello@aesthete-studio.com](mailto:hello@aesthete-studio.com).

## **7. Copyright and Intellectual Property**

- 7.1. The Website, the Services and all of the related products of Aesthete Studio are subject to copyright. The material on the Website is protected by copyright under the laws of Australia and through international treaties. Unless otherwise indicated, all rights (including copyright) in the Services and compilation of the Website (including but not limited to text, graphics, logos, button icons, video images, audio clips, Website, code, scripts, design elements and interactive features) or the Services are owned or controlled for these purposes, and are reserved by Aesthete Studio or its contributors.
- 7.2. All trademarks, service marks and trade names are owned, registered and/or licensed by Aesthete Studio, who grants to you a worldwide, non-exclusive, royalty-free, revocable license whilst you are a Member to:
  - a) use the Website pursuant to the Terms;

- b) copy and store the Website and the material contained on the Website in your device's cache memory; and
- c) print pages from the Website for your own personal and non-commercial use.

7.3. Aesthete Studio does not grant you any other rights whatsoever in relation to the Website or the Services. All other rights are expressly reserved by Aesthete Studio.

7.4. Aesthete Studio retains all rights, title and interest in and to the Website and all related Services. Nothing you do on or in relation to the Website will transfer any:

- a) business name, trading name, domain name, trademark, industrial design, patent, registered design or copyright, or
- b) a right to use or exploit a business name, trading name, domain name, trademark or industrial design, or
- c) a thing, system or process that is the subject of a patent, registered design or copyright (or an adaptation or modification of such a thing, system or process), to you.

7.5 You may not, without the prior written permission of Aesthete Studio and the permission of any other relevant rights owners: broadcast, republish, up-load to a third party, transmit, post, distribute, show or play in public, adapt or change in any way the Services or third party Services for any purpose, unless otherwise provided by these Terms. This prohibition does not extend to materials on the Website, which are freely available for re-use or are in the public domain.

## **8. Privacy**

8.1. Aesthete Studio takes your privacy seriously and any information provided through your use of the Website and/or Services are subject to Aesthete Studio's Privacy Policy, which is available on the Website.

## **9. General Disclaimer**

9.1. Nothing in the Terms limits or excludes any guarantees, warranties, representations or conditions implied or imposed by law, including the Australian Consumer Law (or any liability under them) which by law may not be limited or excluded.

9.2. Subject to this clause, and to the extent permitted by law:

- a) all terms, guarantees, warranties, representations or conditions which are not expressly stated in the Terms are excluded; and
- b) Aesthete Studio will not be liable for any special, indirect or consequential loss or damage (unless such loss or damage is reasonably foreseeable resulting from our failure to meet an applicable Consumer Guarantee), loss of profit or opportunity, or damage to goodwill arising out of or in connection with the Services or these Terms (including as a result of not being able to use the Services or the late supply of the Services), whether at common law, under contract, tort (including negligence), in equity, pursuant to statute or otherwise.

9.3. Use of the Website and the Services is at your own risk. Everything on the Website and the Services is provided to you "as is" and "as available" without warranty or

condition of any kind. None of the affiliates, directors, officers, employees, agents, contributors and licensors of Aesthete Studio make any express or implied representation or warranty about the Services or any products or Services (including the products or Services of Aesthete Studio) referred to on the Website. includes (but is not restricted to) loss or damage you might suffer as a result of any of the following:

- a) failure of performance, error, omission, interruption, deletion, defect, failure to correct defects, delay in operation or transmission, computer virus or other harmful component, loss of data, communication line failure, unlawful third party conduct, or theft, destruction, alteration or unauthorised access to records;
- b) the accuracy, suitability or currency of any information on the Website, the Services, or any of its Services related products (including third party material and advertisements on the Website);
- c) costs incurred as a result of you using the Website, the Services or any of the products of Aesthete Studio; and
- d) the Services or operation in respect to links which are provided for your convenience.

## **10. Limitation of Liability**

- 10.1. Aesthete Studio's total liability arising out of or in connection with the Services or these Terms, however arising, including under contract, tort (including negligence), in equity, under statute or otherwise, will not exceed the resupply of the Services to you.
- 10.2. You expressly understand and agree that Aesthete Studio, its affiliates, employees, agents, contributors and licensors shall not be liable to you for any direct, indirect, incidental, special consequential or exemplary damages which may be incurred by you, however caused and under any theory of liability. This shall include, but is not limited to, any loss of profit (whether incurred directly or indirectly), any loss of goodwill or business reputation and any other intangible loss.
- 10.3. Any information or documentation provided on the Website does not constitute business advice of any kind, and are provided for general information purposes only. Aesthete Studio recommends you seek independent business advice prior to relying on any information or documentation provided on the Website. Aesthete Studio will not be liable in any way for your use of, or reliance upon, the information or documents contained on the Website.

## **11. Termination of Contract**

- 11.1. The Terms will continue to apply until terminated by either you or by Aesthete Studio as set out below.
- 11.2. If you want to terminate the Terms, you may do so by:
  - a) providing Aesthete Studio with Aesthete Studio days' notice of your intention to terminate; and

- b) closing your accounts for all of the services which you use, where Aesthete Studio has made this option available to you.

Your notice should be sent, in writing, to Aesthete Studio via the 'Contact Us' link on our homepage.

- 11.3. Aesthete Studio may at any time, terminate the Terms with you if
  - a) you have breached any provision of the Terms or intend to breach any provision;
  - b) Aesthete Studio is required to do so by law;
  - c) the provision of the Services to you by Aesthete Studio is, in the opinion of Aesthete Studio, no longer commercially viable.
- 11.4. Subject to local applicable laws, Aesthete Studio reserves the right to discontinue or cancel your membership at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Website or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts Aesthete Studio's name or reputation or violates the rights of those of another party.

## 12. Indemnity

- 12.1. Subject to local applicable laws, Aesthete Studio reserves the right to discontinue or cancel your membership at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Website or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts Aesthete Studio's name or reputation or violates the rights of those of another party.
  - a) all actions, suits, claims, demands, liabilities, costs, expenses, loss and damage (including legal fees on a full indemnity basis) incurred, suffered or arising out of or in connection with Your Content;
  - b) any direct or indirect consequences of you accessing, using or transacting on the Website or attempts to do so; and/or
  - c) any breach of the Terms.

## 13. Dispute Resolution

- 13.1. Compulsory:

If a dispute arises out of or relates to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).
- 13.2. Notice:

A party to the Terms claiming a dispute ('**Dispute**') has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.
- 13.3. Resolution:

On receipt of that notice ('**Notice**') by that other party, the parties to the Terms ('**Parties**') must:

- a) Within 7 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- b) If for any reason whatsoever, 7 days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon selection of a mediator or request that an appropriate mediator be appointed by the President of the Australian Capital Territory or his or her nominee;
- c) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a pre-condition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;
- d) The mediation will be held in the Australian Capital Territory.
- e) All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

#### **14. Venue and Jurisdiction**

The Services offered by Aesthete Studio is intended to be viewed by residents of Australia. In the event of any dispute arising out of or in relation to the Website, you agree that the exclusive venue for resolving any dispute shall be in the courts of the Australian Capital Territory.

#### **15. Governing Law**

The Terms are governed by the laws of the Australian Capital Territory. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of the Australian Capital Territory, without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

#### **16. Independent Legal Advice**

Both parties confirm and declare that the provisions of the Terms are fair and reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of inequality or bargaining power or general grounds of restraint of trade.

#### **17. Severance**

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
